Dual Enrollment – AB 288 and non AB 288</p>	<p>Dr. Laura Cantu, K-14 Career Pathway TAP, LACCD Consortium and Team members from East LA College Laura Cantu is the K-14 TAP in LACCD.</p> <p>Work spearheaded by career ladder and RP group to bring together key leads throughout the state to implement AB 288. Their work focused on a global perspective; what is AB 288 and non AB288; DE opportunity for HS students to receive credit for both college and HS but not always HS; opportunity for students to receive free college tuition; to create a college going culture; Lisa Lewenberg brought list of courses on file with LAUSD regarding which courses have been approved by K-12 district to count toward HS graduation. Addressing Special Needs Students in Dual Enrollment Classes</p>	<p>Rio Medina, Career Pathways Coordinator, Long Beach City College</p> <p>Rio presented a power point overview for new process at LBCC; IEP and 504 plans; providing access to all students; 504 and IEP plan is different in how they provide services; less lengthy because these students are integrated in traditional classroom setting vs. students in special education classes or those that require more accommodations; data indicator to make sure we are meeting students’ needs; student’s to self-identify; communication and collaboration; mentors who are counseling interns to work with students with IEP or 504; liability question – is there liability if student does not self-identify, in college students can self-identify and chose which services to use; how does this differ when students are taking classes off campus;</p> <p>Lea Martinez suggested that it would be nice to include in orientation for DE students.</p>	<p>Melissa to send out forms from Marie Tyra.</p>
<p>V. K-12 Career Pathways Strong Workforce Program Trailer Bill a. Current knowledge and rumors b. Recommendations</p>	<p>Overview – Lyla Eddington reminded the group of the 25 recommendations for SWP money with intent to implement recommendations; purpose is to close employment gap. Bill does not clearly define region; states will fund a consortium through a region. Competitive grants are also part of the bill with match requirement; criteria for selection; subcommittees; priority for awarding grants. Also states that there will be workforce pathways coordinators; 1 per district. There is no mention as to how will manage high schools in region and provide oversight like mini grant. Purpose is to expand Strong Workforce Program into K-12.</p>
